Girls in Ocean Science Conference Inspires Emma Lossing to Pursue her Passion

Emma Lossing's connection to SBMM began when she was a young girl visiting from Lompoc. A family sailing trip near the Santa Barbara Channel brought her to the museum for the first time, sparking an early fascination with the ocean and marine life. However, it wasn't until high school that she reconnected with SBMM in a meaningful way. Her aquarium science teacher encouraged her to attend SBMM's Girls in Ocean Science Conference. representing her high school's aquarium science program.



Emma was captivated by the event and recalls being "so amazed" by the program's opportunities. She had expected a day of simple activities, but instead found herself immersed in marine science, going on boat trips, and conducting hands-on research. The experience proved transformative, giving Emma a sense of connection and motivation to make a difference while strengthening her belief in the museum's power to shape lives and foster a deep respect for the environment. "SBMM is improving so many lives," said Emma. "I can see how an impactful gift from a donor today would then empower the next generation of scientists. Flagship Society

The Santa Barbara Maritime Museum Flagship Society is a group of dedicated individuals who have made provisions in their estate plans to ensure the museum continues to educate and inspire future generations about the region's rich maritime history.

To honor those who have included SBMM in their estate plans, the museum:

- Features member names on a special display in the museum.
- Lists members in the museum's annual report and other publications.
- Invites members and their guests to unique receptions.

To join the Flagship Society, an intended donation must include SBMM as a beneficiary. The donation may be an unrestricted planned gift (allowing the museum flexibility to meet its most urgent needs) or a designated planned gift (provided for the museum's endowment, education programs, or to honor a loved one). Planned gifts of \$10,000 or more allow for inclusion in the museum's Flagship Society.



Planned Giving Options

Maximizing your gift and participating in planned giving are strategic ways to leave a legacy while helping to secure SBMM's work into the future. Your Flagship Society gift may also offer you significant tax advantages and can continue to provide income to you and your heirs. Individuals may join the Flagship Society by making contributions to SBMM through one or more of the following planned giving opportunities:

- In your living trust or will.
- Beneficiary of a life insurance policy or an annuity.
- By gifting assets from a tax-deferred retirement plan, such as a 401(k) plan, 403(b), or an IRA.
- By establishing a charitable remainder trust that can provide lifetime income to a loved one as well as a significant future gift to the Maritime Museum.
- As a final legacy in a donor advised fund.
